Easter Lutheran Church Footnotes to Financial Statements For the Fiscal Year Ended June 30, 2021

Note 1. Summary of Significant Accounting Policies

Basis of Statement Presentation/Reporting Entity: The Church uses a modified cash basis for accounting purposes. The Church is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code.

Fund Accounting: For accounting purposes Church assets are segregated into funds according to their uses. These funds are described as follows:

General Operating Fund: This fund accounts for the resources available to carry out the Church's operations.

Capital Fund: This fund accounts for resources used for purchases of real property and related improvements, and for expenses for capital fundraising campaigns. In addition, significant equipment purchases are funded through operating contributions and transferred to the capital fund at year-end.

Easter Foundation: This fund accounts for resources designated for scholarships and endowments.

Investments: Investments are stated at fair market value. The church has investments with the Mission Investment Fund of the Evangelical Lutheran Church in America at varying interest rates and terms and in the ELCA Pooled Trust Fund, as well as Insured Cash Sweep investment accounts through Old National Bank (formerly Anchor Bank).

Fixed Assets: Fixed assets are recorded at cost. Depreciation expense is not reflected in the financial statements.

Retirement Benefits: The Church has a defined contribution retirement plan for eligible employees.

Contributions and donations: The Church records contributions when it has been determined that there is a legal right to the contribution and the amount is subject to reasonable estimation. Therefore, annual promises to give are not recorded until the cash/asset is received. Church contributions are credited to "one fund" from which the Church can allocate appropriate amounts to pay general and building/capital obligations.

Church policy is that contributions of investments are liquidated at the time of the gift and recorded at cash value. The exception to this policy may be contributions made to the Easter Foundation.

The services of volunteers have not been reflected in the statements as donated services since there is no objective measurement basis. Nevertheless, volunteers have given significant amounts of time to the Church.

Note 2. Long-Term Debt

A summary of the long-term debt as of June 30, 2021, is as follows:

Note payable to Mission Investment Fund of the Evangelical Lutheran Church in America, due in monthly installments of \$24,567 through February 1, 2031, including interest at 2.9% (fixed for first 5 years then subject to adjustment), secured by first mortgage.

Easter Lutheran Church Audit Review Committee's Report For the Fiscal Year Ended June 30, 2021

Easter Lutheran Church's (the "Church") Audit Review Committee met on October 26, 2021 to review the financial statements of the Church as of June 30, 2021 and 2020, and related statements of activity for the years then ended. Our review primarily consisted of analytical procedures applied to the Church financial data and inquiries of Church personnel. Our review does not constitute an audit of these financial statements, nor did we attempt to assess these financial statements for conformity with Generally Accepted Accounting Principles. Accordingly, we do not express an opinion on these financial statements.

Church personnel are responsible for the preparation and fair presentation of the financial statements in accordance with the Church's basis of accounting, which is disclosed in the footnotes to these financial statements. Church personnel are also responsible for designing, implementing, and maintaining internal control relevant to the preparation and fair presentation of the financial statements.

Based on our review, we are not aware of any material modifications that should be made to the accompanying financial statements based on the Church's basis of accounting.

LEAD PASTOR'S LETTER



Let us hold fast to the confession of our hope without wavering, for he who has promised is faithful. And let us consider how to provoke one another to love and good deeds, not neglecting to meet together, as is the habit of some, but encouraging one another. – Hebrews 10:23-25a

Once upon a time, about two years ago, I thought there would be some near future in which we would have parties to celebrate all we'd endured and how we became a stronger, closer community because of it. Instead, today I feel like the crises just keep coming. Like many of you, I feel the weight of these struggles and sometimes wonder if things will ever feel stable again.

I rediscover hope when I hear these words from Hebrews. The One who has promised is faithful. We continue to hold fast to the confession of our hope. In all things, at all times, we consider how to motivate each other to deeper love and greater service. Whenever possible, we meet together – in worship, in learning, in service, in person or online, in the community and in our church building, always encouraging one another. And friends, that's something that keeps me focused in the good we continue to do here at Easter Lutheran Church to God's glory.

Or, to put it in the words of a hymn: "No storm can shake my inmost calm / While to that rock I'm clinging / Since Christ is Lord of heaven and earth / How can I keep from singing?" (ELW 763)

And so, let us celebrate those ways we've continued to build upon the rock of our faith, holding fast to our confession of hope, fulfilling the mission God has given us to grow in faith and carry on the work of Jesus Christ.

Pandemic response. For another year, the Safely Reopening Campuses Team has led us through difficult decisions as we balanced public health and community life. Given the many changes in the nature of the pandemic, especially access to vaccines and testing, they consider their work completed. I offer enormous thanks to Dr. Brent Elert, Amy Jacobson, Tom Pederstuen, Allison Butler, Rachelle Gill, Kent Henriksen, Ben Kornelis, and Pastor Brandon Newton for their wisdom, compassion, and guidance through challenging times. It is my dear hope that their services, while appreciated, will not be needed again.

A new Sunday morning schedule. For about a year, we've been trying a new schedule of worship and Sunday morning JAM. The two in-person services reflect reduced attendance, however, having just two services has allowed us to try some very worthwhile things. First, we are now able to have one preacher for all services. I cannot overstate the value of this. It allows the whole congregation to be unified with one message each week, lets the preachers build on each other's sermons from week to week, keeps a three-pastor model possible, and uses the pastors' time most effectively. In whatever way our schedule might change and grow from here, it will be with this practice in place.

Second, we've been able to have JAM scheduled in such a way that families can worship together. Because there is only a small amount of overlap between worship and JAM, families don't need to choose between Christian education for their kids and the ability to be together in worship. What an incredible joy to have people of all ages gathered in worship together!

Finally, we continue to offer a pre-recorded online service each week. We've heard numerous times how appreciated this service is from snowbirds, families needing extra covid caution, residents of care facilities (our service streams in several facilities as their chapel service), members of the community who see us on Eagan's cable channel, and so much more. The

consistently high quality and blended style make it a unique offering. It remains an important part of our weekend worship experience.

Staffing. We have had some transitions on our staff. As of this writing, we are searching for a new Media Specialist to help with our excellent communications work. We also still need a third custodian to help with preschool cleaning, on-call coverage, and general custodial work. However, we also have a brand-new Director of Operations, Gina Lindquist. Her thoughtfulness and focus have already helped us get our large facilities needs well-managed. And finally, we have an otherwise long-serving staff whose talent, passion, faith, and good humor are cause for great joy. One of the greatest resources of this congregation is its people: staff, volunteers, lay leaders, worshipers, members, and you.

Generosity. One of the best seasons of my year is when I get to sign thank-you letters to Easter people who complete a Statement Of Intent. I pray over each letter and praise God for every household who makes this faithful, meaningful commitment. This year, our generosity appeal sought to respond especially to our capital improvement needs, as well as our continuing commitment to outreach and equity, and sustained ministry excellence. You truly heard the Spirit's call to be a part of this good work. I celebrate your continuing trust in God made known in your financial giving. When we put God's gifts to good use among us, there's no limit to what this congregation can do in service of the gospel.

As I consider the year to come, I have two things on my mind and ask that you would join me in prayer and discernment as we seek where God leads us:

Renewal and reconnection. The past few years have been full of transition and disruption. Who we are as a faith community has changed. What is God up to among us now? You may have noticed that we've started to ask that question more vocally, whether during our Lenten series or in the survey that went out in March. Through the summer, our Vision Board will keep asking those important questions through a series of listening sessions that I hope you'll join.

I have always resisted calls to "return to normal." I'd rather we consider where the Spirit leads us today. I believe we can honor our history, be realistic about our present, and boldly follow God into our unified future – but it means we must pay attention, listen to each other and the Spirit, and be willing to try new things while letting some things go. This important renewal work allows us to reconnect with our congregation, our community, and who God calls us to be.

Facilities. The challenge of our two sites and their numerous improvement needs cannot be overstated. This will involve financial investment from our congregation as well as important, weighty decisions about how we use the physical resources God has gifted us. When I consider the meaningful worship, life-giving outreach, powerful teaching, and joyful fellowship that happens in these walls, I know it's all worth it.

We have work to do together, Easter people. But it's work worth doing. And while the world around us tries to shake us, we know that we can hold fast to the rock of our faith in Jesus Christ. Centered in this hope, we can continue to encourage each other to ongoing acts of love, knowing and trusting that we're better together.

I praise God for you and am humbled by the opportunity to be your pastor. Thank you for your continuing prayers, generosity, volunteer service, personal devotion, and commitment to the life of this congregation that we all love so much.

The Vision Board has spent time this past year discussing and strategizing about how to hear more directly from the Easter community. This summer, we plan to engage in listening sessions around open questions that will help inform what we vision into the future. We desire this to be an ongoing event, perhaps annually, to create a culture of sharing and listening. We are excited to learn more about what you most appreciate about Easter, as well as areas that could be more developed. Although the details have not been yet confirmed, please look to the summer to participate in one of the listening sessions.

It has been a privilege to serve as the Vision Board's president this year and to work alongside other faithful, Easter-loving people on the board. The work of the Vision Board is not particularly glamorous, but the conversations and commitment to the mission and vision of Easter Church make me so proud and blessed to be part of this group.

My prayer for Easter is that we continue to connect with one another, in person or online, across our ministries so that we may engage our hearts, our minds, and our hands as we seek to grow in faith and carry on the work of Jesus Christ.

FAITH FORMATION TEAM

Including: Kid's Ministry, Confirmation, Youth, and Adult Ministry

Faith Formation Team (Submitted by: Pastor Steve Thomason)

One of the biggest shifts over the past year has been the ongoing development of a Faith Formation Team and unified vision of faith formation at Easter. Prior to this year there has been a sharp distinction between the work of the Family Ministries Team—Kids Ministry, Confirmation, and Youth Ministry—from the work of Adult Ministries. In July of 2020 the supervision of Adult Ministries staff officially shifted from Pastor Brandon to Pastor Steve. The 2020-21 season was marked by two significant factors. First, the pandemic made adult ministry and connection very difficult. Second, Amy Vigesaa announced her resignation as Adult Ministries Director. We spent most of the year revisioning the Adult Ministries Director job description and searching for a new director.

We hired Jami Day as Adult Ministries Director in May, 2021. This past year we have focused on two primary goals: First, help Jami learn about Easter Lutheran Church and successfully step into her new role; Second, begin building a unified vision of faith formation at Easter for all ages.

That unified vision became the Faith Formation Team, comprised of Kid's Ministry Staff (Rachelle Gill and Sara Currell), Youth Staff (Hans Vigesaa and Allison Butler), and Adult Ministries Staff (Jami Day), led by Pastor Steve. While each ministry area continues its unique ministry, the collective team focuses on faith formation ministry that spans specific demographics. Our first successful event was a unified Small Group Leader Launch in September and a Small Group Leader Refresh in January.

Our Faith Formation Team mission, as a subset to the mission of Easter to grow in faith and carry on the work of Jesus Christ, is to cultivate dedicated disciples of Jesus, equipping them to discern what God is doing in the world and empowering them to join it. There are four key pillars to our ministries: Relationships, Reflection, Spaces, and Pathways.

Now that we have laid the groundwork for the Faith Formation Team, we are hopeful to launch the following initiatives in the coming year:

A Small Group Leader Training curriculum that can be completed online or in person.

• Cultivation of the Family Experience, seeing it as a place to minister to children and cultivate new Family Life Groups.

• A strategy to connect baptism families in meaningful conversations and/or life group experiences that will help them be more equipped as parents and more connected to the congregation.

• A strategy to connect new members into meaningful conversations and/or life group experiences that will help them to grow in their faith and feel more connected to the congregation.

• Exploration of a strategy for cultivating both a parenting ministry and a marriage enrichment ministry. Both of these ministries are prime examples of the intergenerational aspect of Faith Formation and the joint efforts of each unique ministry area.



KIDS MINISTRY

Submitted by: Rachelle Gill Kids Ministry Director Report for the 2021-2022 Program Year

What effect did the pandemic continue to have on this ministry area, and what, if any, effective modifications did you continue to use or add?

Families are overwhelmed deciding the best and safest ways to take care of their children. To help ease these chaotic times, we have developed ways families can grow in faith together. Family VBS, Take Home Advent kits, JAM(Jesus and Me Christian instruction) as a family, POP UP Christmas are just a few examples of ways families can make memories together.

What were this ministry area's most significant accomplishments for the year?

The Kids Ministry Team (volunteers and staff) communicates regularly with families (via zoom, phone calls, text and emails) to discuss a variety ways to encourage engagement of families and the community. *It is vital for our faith community to be a part of the process.*

• The Family Faith Formation Team has developed a path for parents to see "what's next" in their child's faith journey. The Stepping Stones of Baptism, Preschoolers learning about prayer, giving Bibles to 3rd graders, First Communion and Moving Up 5th graders has allowed us to create space for connection and a sense of community.

• Great participation developing the Easter Celebration and Egg Hunt to a totally outside event.

Despite the pandemic swirling around us - VBS filled up fast as we "ARMORED Up for God."

• Engaging new parents, via zoom or safely in person, for Baptism classes 4 times a year has been fantastic. This is an important "cornerstone" to welcome families into the Body of Christ and the mission we share: To Grow in Faith and Carry on the Work of Jesus Christ!

• Families now experience the sacraments of our faith, together, when JAM started last fall.

• Our youth (grades 6-12) have stepped up and said YES to being a JAM Small Group Leader, filling in for parents who's time availability would not allow another commitment.

What is God calling you to do in the year ahead? What are your most exciting goals?

• Working closely with the entire Faith Formation Team!

• Forming ministry around new relationships, reflection, spaces and pathways as the four pillars of faith formation.

Help kids to learn about God, love God, and follow Jesus. Connecting kids to caring adults who can help them understand how faith connects to their every day life.

• Assist in Partnering with Parents, to model what faith looks like to their children. Proverbs 22:6 says "Start children off on the right path. And even when they are old, they will not turn away from it."

• Develop a Family Experience (FX). FX allows for families to come into our church community no matter where they are in their faith journey. FX includes single parents, new parents, grandparents, foster parents, legal guardians, and kids of every background imaginable.

• The ultimate goal for FX – is to create a culture of inviting <u>others</u> to have fun all <u>together</u>.



CONFIRMATION Submitted by Pastor Steve Thomason Report for the 2021-2022 Program Year

What effect did the pandemic continue to have on this ministry area, and what, if any, effective modifications did you continue to use or add?

For the Camp Track: We were very happy to be able to send our Camp Track students for a week to Camp Wapo in August. We remained masked and spread out in small groups during our teaching time. We also offered a Zoom Camp option for families who were not comfortable with sending kids to camp. I took my computer to Camp and led a group of students through the day's lesson on one Zoom call.

For Wednesday Night Track: We decided to reduce the Fall retreat from a two-night event to a one-day experience at Camp Wapo. This relieved some family's stress over the idea of having students sleeping in cabins and breathing each other's air all night. We remained masked during the regular Wednesday night sessions, but that was the only modification we made for this season. It was good to be in person again.

For Ninth Grade: Students had to make church visits virtually again this year. This significantly diminishes the impact of the experience. All other activities were able to be in person. The plan is to reboot the Relationship Retreat on April 8-10, 2022 at Wapo, after two years of COVID shut down and adaptation.

For 10th Grade: We remained masked during the one-day retreat at Mt. Olivet Retreat Center. We also had a shortened Confirmation Ceremony in which we did not serve communion or have students come forward for the laying on of hands. Each student sat with their family throughout the service.

What were this ministry area's most significant accomplishments for the year?

51 students affirmed their baptism in October and became adult members of Easter. A special thanks to the 9 adult mentors that led these students through the Journey to Confirmation from 6-9th grade.

• 41 adult mentors loved and led 225 students in 30 small groups of students through the program this year.

- We transferred leadership of the Camp Track from Pastor Steve to Hans Vigesaa.
- Successfully returned to in-person learning for all Confirmation tracks.

What is God calling you to do in the year ahead? What are your most exciting goals?

Seeking to transfer leadership of the Confirmation program in total from Pastor Steve to a joint team of Hans Vigesaa and Allison Butler.

o Hans will be the lead teacher and responsible for either teaching the lessons or scheduling the pastors and other leaders to teach.

o Allison will be the Confirmation Coordinator and responsible for administration of the entire Confirmation Program.

o This shift will allow Pastor Steve to focus on broader Faith Formation Ministry with vision and strategy.

Updating the Faith Journey website to be more user friendly and engaging for students.



YOUTH Hans Vigesaa Report for the 2021-2022 Program Year

The pandemic continues to affect nearly every aspect of this ministry. Starting with regular programing, YOWIE attendance fell by quite a bit. Whether it was parents keeping kids safe at home or students mentally and physically exhausted from school, YOWIE attendance was very low. Other retreats or most programming pieces, both HS and MS, that were expected to happen this past year were again cancelled.

Much of YOWIE programming revolved around being available and tending to the wounds caused by the pandemic, mental, physical and spiritual. So, programming looked like - creating painting parties, doing yoga, watching movies, meeting in person as much as possible and creating space to unwind and relax.

Middle school events were hit even harder. Besides regular confirmation nights and days that gathered middle schoolers, only one non confirmation event was able to be scheduled and realized.

Last summer we were able to do one High School and one Middle School mission trip and these were fantastic and so life giving. We were also able to go back to Bemidji in the fall to visit our friends and ministry partners and reconnect after missing them for so long.

What were this ministry area's most significant accomplishments for the year?

I think one of the consistent themes throughout the high school year is that we are committed to meeting in person, as safely as possible, as much as possible. We continued to show up weekly despite our own exhaustion and disengagement. We continued to remind kids they are loved, that they are valuable and that they are not alone.

And as stated, having mission trips in the summer and our servant adventure to Bemidji last fall were fantastic.

What is God calling you to do in the year ahead? What are your most exciting goals?

Attendance and engagement are two words that we confront and are haunted by weekly. One of the long time program pieces that was not immune to this was TIM Team – our high school peer leadership group. Nearly every upperclassmen resigned from TIM team. So, a focus this year is restructuring TIM team, as they are such a valuable and vital piece of ministry at Easter. Companion to this is finding ways for teens to engage, finding space to talk about their faith and discover and name what God is doing in their lives.



ADULT MINISTRY

What effect did the pandemic continue to have on this ministry area, and what, if any, effective modifications did you continue to use or add?

In May of 2021, I began my role as Adult Ministries Director, under the supervision of Pastor Steve Thomason. He painted a picture of the history and current landscape of this ministry. This tool was extremely helpful in creating a big picture of the ministry and how it fits into his vision for the entire Faith Formation Team. Due to the pandemic, my objective for the programming year was to keep the status quo and simply observe. From my observations, the pandemic led to slightly lower participation and a change to a Zoom format for some programs when the Omicron hit in January.

What were this ministry area's most significant accomplishments for the year?

We invested time calling all Life Group leaders to get feedback and contact updates for our church database. We updated the website to make it more user friendly and introduced the Easter Connect tool to all Life Groups and other Adult Ministry programs. The most significant accomplishment was the tenacity, creativity and commitment of our volunteer leadership teams; Man Up (Tom Yelle and Mark Dean), Soul Sisters (Amy Young, Merri Guggisberg, Janet Yelle and Beth Dean), Table Talk (Judy Englund and Dave Montgomery) and WOW Bible Study (Laurie Martinson and Kim Becker). Jerry Friest also created and is currently leading a very popular study for our 55+ members on Zoom. We've created a monthly email for Life Groups called "Ideas" to equip them with resources to grow their faith and carry on the work of Jesus Christ.

What is God calling you to do in the year ahead? What are your most exciting goals?

I am excited to explore how Adult Ministries will grow under the Faith Formation Team umbrella. Starting in March of 2022, I will be joining the Faith Formation Team for monthly meetings to begin this journey together.



OUTREACH REPORT

Rhonda Doran, Director of Outreach Report for the 2021-2022 Program Year

What effect did the pandemic continue to have on this ministry area, and what, if any, effective modifications did you continue to use or add?

This program year called for continued flexibility, creativity, and willingness to shift between approaches as we rode the waves of the pandemic.

LOCAL PARTNERSHIPS

The continued pandemic highlighted the importance of our local partnerships. Opportunities to interact with and collectively support our community brought hope and connection. Homework Help staff and volunteers met with students through distance learning and began to safely meet in person. The TreeHouse program offered support to teens from a distance and in small groups, then moved to a more traditional group model. Loaves and Fishes continued to offer meals curbside. Fare for All adjusted its schedule and offered curbside pick-up as well. The Red Cross modified the blood drive registration and check in process while responding to increased need for blood. The Open Door increased capacity and adopted innovative solutions to feed more people than ever before.

GLOBAL PARTNERSHIPS

In-person travel and visits with our partner congregations were not an option, so we relied on increased use of technology and online opportunities for connection. We shared videos with our partners and began hosting Zoom sessions to allow Easter people to connect with the members of our partner congregations in Guatemala and Tanzania.

JUSTICE & EQUITY

Options for in-person meetings and experiences remained elusive, so we offered online options for learning and engagement.

What were this ministry area's most significant accomplishments for the year?

Across our Outreach ministries, we connected with our neighbors through deepened partnership and collaboration despite the pandemic. We increased focus on open communication and dialog, seeking to listen to our partners and the communities they represent and embracing the assets they bring to our partnership.

LOCAL PARTNERSHIPS

We focused on community building events with partners that share our space: Easter Preschool, Hispanic Church, Homework Help by Reaching Up, Loaves and Fishes, and TreeHouse. We shifted our focus to acknowledge community assets and better support our partners in ways that respond to our community's voice and needs.

GLOBAL PARTNERSHIPS

We increased opportunities for congregational interaction through technology while continuing to provide financial support for partner congregations and maintaining commitment to scholarships for students in Tanzania.

JUSTICE & EQUITY

We were inspired by the adoption of Easter's resolution that serves as our guiding document and commitment to look inward, educate ourselves, build relationships, and promote equity. We offered book discussions, guest speakers, community events, listening sessions, and opportunities to engage in group and personal development through the Center for Leadership and Neighborhood Engagement and the Intercultural Development Inventory.

What is God calling you to do in the year ahead? What are your most exciting goals?

God is calling us to renewed commitment and intentionality in relationship building; really getting to know the communities that share our space, our local community, and our Lutheran faith in Guatemala and Tanzania.

LOCAL PARTNERSHIPS

Locally, we will offer more community events and opportunities to meet and listen to one another. Better listening means we will improve the ways we respond to the needs of our community and gain understanding of the gifts our community shares with us.

GLOBAL PARTNERSHIPS

Globally, we will continue to provide online opportunities for more Easter people to get to know our brothers and sisters in Guatemala and Tanzania. We'll begin to travel again and walk alongside our partners in person, starting with a February 2023 trip to Guatemala.

JUSTICE & EQUITY

We will provide resources and learning opportunities for adults, kids, and families, build on our current partnerships, and increase intercultural competence through exposure to other cultures. We will offer Easter people opportunities to expand our learning, broaden our perspectives, and engage in difficult conversations.



CARE AND SUPPORT MINISTRY

Submitted by: Pr. Brandon Newton, Community Care Pastor Report for the 2021-2022 Program Year

What effect did the pandemic continue to have on this ministry area, and what, if any, effective modifications did you continue to use or add?

• A goal from last year was to launch a respite companion program to support caregivers. Through our Community Care Corps Grant and partnership with Lutheran Social Services of Minnesota, Easter members Heather Boyum and Angie Swetland were trained as Respite Education Support Tool trainers. The next step was to train Easter volunteers to provide respite care. Given covid precautions, I was not comfortable sending new volunteers into the homes of people who would likely already be more vulnerable to covid infection.

Another goal from last year was to add two new senior living facilities to host worship. Many facilities closed to non-essential visitors which made expanding this program difficult. Once facilities opened we were able to add one new location.

• Support Groups have been moving back and forth between Zoom and in-person depending on positive case counts in Dakota County, though most are meeting in-person again.

In-person visits from BeFrienders and Care Team Visitors have depended on the comfort level of volunteers and visit recipients.

Hospital visits were on and off throughout the year—some hospitals allowed only one family visitor or allowed outside clergy depending on covid case counts. This was a moving and exhausting target throughout the year.

• As in-person ministry for older adults resumed, several of the ipad recipients transitioned away from their ipads and happily returned to in-person ministry groups.

What were this ministry area's most significant accomplishments for the year?

• Led a special worship service for remembrance and healing on November 2nd. BeFrienders were available to anoint and pray with parishioners.

• Added a new location for hosting Easter's pre-recorded worship service. In addition to the first Sunday each month at Stonehaven, volunteers host worship in the movie theater at Eagan Pointe the first and third Tuesday each month.

Joined the waiting list for congregations willing to lead worship once every nine weeks at the Dakota County Jail.

• Blessed 57 prayer blankets for distribution to those on the prayer list (a record number of prayer blankets).

• Trained and welcomed three new BeFriender Ministers.

• Care Team visitors resumed in-person monthly visits to parishioners.

• Partnered with Shepherd of the Valley Lutheran to offer a pre-marital preparation retreat for nine engaged couples.

What is God calling you to do in the year ahead? What are your most exciting goals?

• I am hoping to launch a Group Respite Program in the fall by partnering with DARTs. This would be offered the 1st and 3rd Friday each month from 10am-2pm at Easter by the Lake. Trained Easter volunteers would be paired with participants for activities. Caregivers would also be invited to attend a support group for the first hour.

• Expand the worship hosting program to two new facilities. This is part of a long-term plan to bring Easter's online worship to people who cannot get to our buildings.

Work with Dakota County to assess needs in county-affiliated senior living facilities. These facilities do not have a full-time activities director to help build community. Perhaps there are opportunities for Easter ministries to help build community among residents.

• Merge our Care Team Visitors and BeFriender Ministers into one ministry group with shared

trainings, resources, and purpose.

• Begin a Face-It support group for men living with depression.

• Explore opportunities to support those living with addiction through the Center of Addiction and Faith.

COMMUNICATIONS REPORT

What effect did the pandemic continue to have on this ministry area, and what, if any, effective modifications did you continue to use or add?

Throughout this year Communications was challenged by the lower in-person attendance, thus limiting views on announcements. We struggle to make certain our community knows what is happening and how they can be involved.

What were this ministry area's most significant accomplishments for the year?

We reduced the in-person bulletin and moved announcements fully to electronic delivery, allowing printing to remain minimal. We plan to continue using digital communications methods and use screens during worship.

Throughout the pandemic, we have created and curated content that received over 75,000 views. Consumption increased across all our digital platforms, including the website, Facebook page, YouTube channel, and Instagram page.

We introduced a new APP: Easter Connect, with the goal of "building community online." Currently there are 492 members. As the year has progressed Easter Connect has evolved to be a place for Curriculum, Classes, and Staff created publications.

As online worship continued, we worked to make prerecording easier and friendlier for every viewer. Bringing in volunteers from all areas of the congregation was important to us, so we started regular recording sessions to gather those videos.

MINISTRY REPORT EASTER JOB TRANSITIONS GROUP

Prepared by Denise Sjoberg Report for the 2021-2022 Program Year

The Easter Job Transitions Group began in the depths of the Great Recession in December of 2008, when Catherine Byers Breet was called to offer her expertise to church members once a month. What started as an informal group soon turned into a weekly event, which sometimes drew as many as 100 people.

Over the past 13 years, we served thousands of job seekers, and many of them stay in touch via our group on LinkedIn. Over 100 different speakers have shared their professional advice on topics ranging from resume writing, interview tips, mental health care and many others.

During the pandemic, the group met virtually via Zoom, providing a lifeline to people who not only lost their jobs but were isolated and afraid.

The last months of 2021 showed a very marked decline in the number of people attending not only the Easter group, but job groups across the country.

In September when attendance at our group was less than 10, we decided that it was time for our group to fold and encourage folks to join other groups.

We served the job seeker community faithfully and consistently since 2008, and found it time to turn the reins over to others. We reluctantly yet peacefully decided that our job group fulfilled its purpose and ended our service on October 27, 2021.

Immense thanks to Catherine for her leadership, Terry Schumacher for consistently welcoming new folks each week, and Tim Voit and Kathleen Brogan for being present each week to lend a hand wherever needed.

WORSHIP COMMITEE REPORT

Submitted by: Joseph Witthuhn, Chair Report for the 2021-2022 Program Year

What effect did the pandemic continue to have on this ministry area, and what, if any, effective modifications did you continue to use or add?

Although we have begun to see things slowly return, the pandemic has continued to have a sizeable impact on worship and how we deliver the experience. Staff and health experts have largely driven the decision-making process related to what we can and cannot do in-person. Easter has done a good job of bringing back safe, in-person worship options for those who are comfortable returning to an in-person setting, while continuing to offer on line worship options for those who are not (or those who cannot do so safely). We continue to assist with set-up and tear-down for special services, making adjustments such as masking and social distancing.

What were this ministry area's most significant accomplishments for the year?

• Despite the pandemic, performed setup and tear down tasks for services, including Lent, Holy Week, Easter, Reformation Sunday, All Saints' Day, Thanksgiving, Advent, and Christmas

• Provided planning and support for the reopening of in-person worship, including rethinking layouts for communion

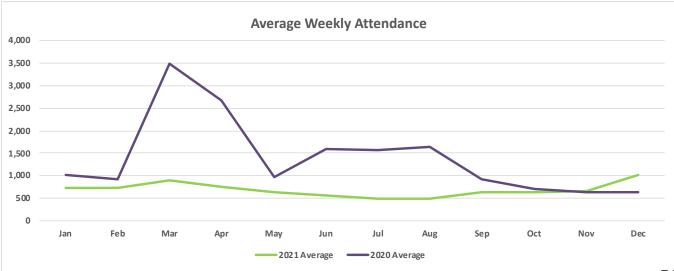

Report of Director

Summer of 2020 was spent reading COVID protocols from the CDC, MN Department of Health and MN Department of Human Services. Combining the information we came up with a plan to keep kids, families and staff as safe as possible. Separating classrooms, keeping adults out of the building, cleaning toys daily and requiring teachers to wear masks were just a few of the adjustments made to our day.

The teachers were true champions. Nancy Hensch, Theresa Glavan, Darla Landmark, Cindy Olson and Patty Goehring were committed to returning to the classroom regardless of the risk and uncertainties the year was bringing. Enrollment declined throughout the summer forcing us to combine classes to a MWF am and TTh am session. Afternoon classes and lunch bunch were canceled. The hardest news to deliver was the cut in teacher hours. Good news came at the end of 2021 when the Board announced the decision to use grant money to restore some of the money lost when teacher hours were cut.

We closed one classroom for a total of 14 days due to one teacher with a positive COVID case in November 2021. There were no other closures. More good news came when the Easter Preschool staff was chosen as some of the first recipients of the COVID-19 vaccine at the end of January 2021. Summer camps were offered for one week each in June, July and August taught by Nancy Hensch and Theresa Glavan. Registrations were filled instantly. We continue to be grateful for the hard work and decisions made by the Preschool Board. We are also grateful for Megan Brewster's work as our bookkeeper

Resolution 2 – General Operations (Ministry and Benevolence) and Building Operations Budgets for Fiscal Year 2023

Explanatory Information

This budget resolution comes for consideration and approval by the 2022 Easter Lutheran Church annual meeting.

Easter Lutheran Church regularly projects income and expenses for ministry on a fiscal year basis, July 1 – June 30;

Income

Easter Lutheran Church has conducted a generosity appeal for all member giving for the calendar year 2022 for a projected member income of \$1,751,200 allocated to the General Operations Budget and \$442,700 allocated to the Building Operations Budget for fiscal year 2023;

Easter Lutheran Church estimates other revenue from fees, programs, and other giving of \$232,993 and \$38,400 from Designated Gifts for a projected total General Operations income of \$2,022,593;

Easter Lutheran Church estimates revenue from other sources of \$840 for a projected total Building Operations income of \$443,540;

Expenses

Easter Lutheran Church has projected General Operations expenses based upon experience, ministry needs, program requirements and opportunities for growth in ministry of \$2,022,550;

Easter Lutheran Church has projected Building Operations expenses of \$443,540 for payment of mortgage obligations (principal and interest) and other building needs such as building maintenance and improvements;

Summary

As a result, the Vision and Financial Boards recommend this Fiscal Year 2023 budget for adoption;

Easter Lutheran Church hereby adopts the General Operations Budget of \$2,022,550 and Building Operations Budget of \$443,540 as supported by the accompanying budget summary detail.

Benevolence

Easter Lutheran Church is resolved to tithe the first 10% of General Operations Budget allocated member giving to local and global ministry partners (including the Evangelical Lutheran Church in America and the Saint Paul Area Synod).



RESOLUTION 3 – NOMINATION BY ACCLAMATION

Bylaw V of Easter's Constitution states:

"The Nominating Committee shall publish its list of nominees at least three weeks prior to the election meeting with provision for additional nominees."

Therefore, the Nominating Committee will present its list on April 3. The list will be available as a separate document, either online or at the church office.

The Bylaw also states that "Any voting member of the congregation may submit to the Nominating Committee additional name(s) for the ballot which shall be placed into nomination by the committee along with the previously published list, provided that:

1. Such names are submitted at least ten days before the election;

2. Such members are eligible and willing to serve. The final nominations list shall be posted at least one week prior to the election."

Therefore, if any other names are submitted, they must be presented to the Nominating Committee by April 14. A final list would be made available to the congregation on April 17.
