Special Congregational Meeting Minutes February 4, 2024

Whereas, additional expenditures in excess of 20% of the annual budget are necessary for HGA Architects and our Easter Design Committee to move forward with the schematic design development and plans and specifications phases of the One Easter project, as well as additional expenses related to pre-design/construction work (such as soil samples, permits, etc.); Whereas the primary project funding sources are connected to the capital appeal, sale of the hill site, and cash reserves; Whereas, the Vision Board supports the approval of these additional expenditures;

VI. Motion and Discussion

MOTION was made and seconded:

As recommended by the Vision Board, approve spending to continue the One Easter project through 30 April 2024 not to exceed \$500,000

-Cathie called for discussion or comments; none received.

VII. Vote and Results

-Each Member participating in the meeting by in person attendance was provided the opportunity to cast a "yes" or "no" vote to the MOTION by paper ballot.

-Each Member participating in the meeting by on-line attendance was provided the opportunity to cast a "yes" or "no" vote to the MOTION by a designated on-line/electronic process.

- -Votes were tallied by Vision Board members and provided to Cathie.
- -Cathie reported the results to those in attendance:

Easter Lutheran Church Footnotes to Financial Statements For the Fiscal Year Ended June 30, 2023

Note 1. Summary of Significant Accounting Policies

Basis of Statement Presentation/Reporting Entity: The Church uses a modified cash basis for accounting purposes. The Church is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code.

Fund Accounting: For accounting purposes Church assets are segregated into funds according to their uses. These funds are described as follows:

General Operating Fund: This fund accounts for the resources available to carry out the Church's operations.

Capital Fund: This fund accounts for resources used for purchases of real property and related improvements, and for expenses for capital fundraising campaigns. In addition, significant equipment purchases are funded through operating contributions and transferred to the capital fund at year-end.

Easter Foundation: This fund accounts for resources designated for scholarships and endowments.

Investments: Investments are stated at fair market value. The church has investments with the Mission Investment Fund of the Evangelical Lutheran Church in America at varying interest rates and terms and in the ELCA Pooled Trust Fund, as well as CDARS and Insured Cash Sweep investment accounts through Minnwest Bank.

Fixed Assets: Fixed assets are recorded at cost. Depreciation expense is not reflected in the financial statements.

Retirement Benefits: The Church has a defined contribution retirement plan for eligible employees.

Contributions and donations: The Church records contributions when it has been determined that there is a legal right to the contribution and the amount is subject to reasonable estimation. Therefore, annual promises to give are not recorded until the cash/asset is received. Church contributions are credited to "one fund" from which the Church can allocate appropriate amounts to pay general and building/capital obligations.

Church policy is that contributions of investments are liquidated at the time of the gift and recorded at cash value. The exception to this policy may be contributions made to the Easter Foundation.

The services of volunteers have not been reflected in the statements as donated services since there is no objective measurement basis. Nevertheless, volunteers have given significant amounts of time to the Church.

Note 2. Long-Term Debt

A summary of the long-term debt as of June 30, 2023, is as follows:

Note payable to Mission Investment Fund of the Evangelical Lutheran Church in America, due in monthly installments of \$24,567 through February 1, 2031, including interest at 2.9% (fixed until March 2026 and then subject to adjustment based on current market rate), secured by first mortgage.

Based on our review, we are not aware of any material modifications that should be made to the accompanying financial statements based on the Church's basis of accounting.

Resolution 2 – General Operations (Ministry and Benevolence) and Building Operations Budgets for Fiscal Year 2025

Explanatory Information

This budget resolution comes for consideration and approval by the 2024 Easter Lutheran Church annual meeting.

Easter Lutheran Church regularly projects income and expenses for ministry on a fiscal year basis, July 1 – June 30;

Income

Easter Lutheran Church has conducted a generosity appeal for all member giving for the calendar year 2024 for a projected member income of \$1,889,000 allocated to the General Operations Budget and \$124,900 allocated to the Building Operations Budget for fiscal year 2025;

Easter Lutheran Church estimates other revenue from fees, programs, and other giving of \$242,138 and \$37,000 from Designated Gifts for a projected total General Operations income of \$2,168,138;

Easter Lutheran Church estimates revenue from other sources of \$7,200 for a projected total Building Operations income of \$132,100;

Expenses

Easter Lutheran Church has projected General Operations expenses based upon experience, ministry needs, program requirements and opportunities for growth in ministry of \$2,006,035;

Easter Lutheran Church has projected Building Operations expenses of \$132,100 for payment of mortgage obligations (principal and interest) and other building needs such as building maintenance and improvements;

Summary

As a result, the Vision and Financial Boards recommend this Fiscal Year 2025 budget for adoption;

Easter Lutheran Church hereby adopts the General Operations Budget of \$2,006,035 and Building Operations Budget of \$132,100 as supported by the accompanying budget summary detail.

Benevolence

Easter Lutheran Church is resolved to tithe the first 10% of General Operations Budget allocated giving (member and non-member/loose) to local and global ministry partners (including the Evangelical Lutheran Church in America and the Saint Paul Area Synod).

LEAD PASTOR REPORT

Submitted by: Pastor Megan Torgerson, Lead Pastor

There is one body and one Spirit, just as you were called to the one hope of your calling. Ephesians 4:4

Over the past year, I've had the privilege of being part of a program called Contemplative Clergy Renewal at Holy Wisdom Monastery near Madison, WI. It has been a meaningful and perspective-changing year of classes, retreats, cohort sessions, and personal renewal. One of the ideas that has come out of this year of reflection is the idea that the *interruption is an invitation*.

This has become especially meaningful over the last year as it sometimes feels like ministry is constantly interrupted. Helping new pastors settle into ministry, getting a building project launched, setting a capital appeal in motion, hiring new staff members – when am I supposed to do ministry with all this interruption? That's when I remember: the interruption is an invitation. These new things aren't exceptions to ministry. They *are* ministry. New pastoral and staff leadership, planning for the building that will serve Easter's mission for years to come, inviting the whole community into financial generosity, and following the Spirit's lead at every turn – this is an invitation into God's mission with us.

We are all being invited into God's work in the world. The interruption to what we know might feel challenging and even be full of grief and anxiety, but it is also an invitation to consider what God has planned for us next. Together, as one community, we keep watching and listening for the many ways our one God interrupts our habits and expectations, inviting us into new and powerful ways to love, serve, share, accompany, and celebrate as God's beloved. Our capital appeal theme verse, Ephesians 4:4, continues to guide us, reminding us that even interruptions point us towards the **one hope** we have as **one people** united by our **one God**.

As I write this report, plans continue to form as capital appeal work and building designs continue to shape. Still, it is my pleasure to reflect on the good work that has been done as we keep looking ahead to where God leads us next.

One Easter One Mission capital appeal. Since late last summer, Easter staff and leaders have worked with GSB Fundraising and Consultants to bring the whole Easter community together in financial generosity. As of this day, we are halfway to our goal, and commitments continue to come in. No matter when you read this, you are invited to be a part of the appeal. I welcome you to contact the church office or go to <u>easter.org/onesite</u> to make your commitment.

But the bottom line hasn't been the only benefit of this work. I've seen Easter come together in an exciting, joyful way. Whether it was the exuberant day of inspiration bag deliveries, the powerful *Generosity Brings Joy Storybook*, the incredible One Easter speakers in worship, or the excitement of our One Easter Worship and Festival, I keep seeing smiles, hearing enthusiasm, and praising God for the good things happening at Easter. This capital appeal has brought us together and reminded us of the good we truly have here in this community.

Enormous thanks go to Dave Unmacht, the appeal chair, as well as Brian & Kari Eickhoff, Tom & Jane Freeberg, Bruce & Laurel Gaard, Joy & Bill Korte, and Barb Moon for serving on the capital appeal steering team. Thank you also to the multitude of volunteers who delivered bags, recruited

helpers, made plans, collected stories, and called us all together as one generous, caring, joy-filled community. I am filled with gratitude for every single one of you who has made a financial commitment to this building project which is many years in the making, and to Easter's annual ministry. Together, we are building the facility that will love our neighbors and preach the gospel for generations to come.

One Easter building project. This year saw a major, exciting transition in our building work. Our Physical Development Task Force, a continuation of a group formed in 2018, got Easter back on track in our one site work. I am incredibly grateful to Cathie Ford and Gary Ehret, the co-chairs of this group, along with Sara Anderson, Abby Andrus, Mitch Berger, Derek Boeve, Sheila Gullickson, Scott Lanners, Jim Mattson, Brenda Misukanis, and John Rollie who all served on the PDTF at some point in the process. Your hard work carried us far.

We have now moved into design work, where we take our original large-scale plans and refine them into specific floorplans and details. We also continue to manage the finances that help us achieve our dreams. Thank you to Cathie Ford and Gary Ehret for continuing to guide this work, along with Mitch Berger, Rick Dahl, Rachelle Gill, Neil Groon, Rolf Lokensgard, Sheryl Johnson, and Jason Staebell for serving on the Design Team. Derek Boeve, Darci Dawson, Dean Hoffrogge, Scott Lanners, and John Rollie faithfully tend to the financial planning. Together, this ever-growing group of volunteers and staff faithfully share their time, talent, and insight to help Easter live into its reality as a united, community-centered congregation where all are welcome.

Currently, building plans continue to form. We've had incredible input from staff and volunteers to help us refine what our new facility will look like. Every time I envision the new space – offices that bring staff together, a sanctuary that celebrates both traditional and contemporary worship, classrooms that promote learning for everyone from preschool to OWLs, enough gathering space for Sunday morning coffee and funeral families, all enjoying the beauty of creation at Thomas Lake – I get excited all over again.

I recognize that this opportunity comes with loss. Celebrating something new means letting go of something we love. Even as we build a new facility, we prepare to leave the Hill site. It has meant so much to Easter's history. Not only is it where we have had baptisms, funerals, weddings, and holidays, but it is the original location where Easter began as a formal church. It won't be easy to say goodbye. Together, we will tell stories, share memories, pray, grieve, and make sure that what we love about Easter can continue in a new space as we entrust our Hill site to a new faith community.

For now, we anticipate having more time to do ministry out of the Hill site. While new construction at the Lake site may be completed by the end of 2025, we're negotiating sale options that keep us in the Hill as long as possible. I hope this eases the transition and gives us enough time to say goodbye to a building that has served us – and the gospel – incredibly well.

Fifty years of Easter. This year sees a string of dates which marked Easter's formal beginnings as a church fifty years ago. While Easter had been worshiping before 1974, this year saw milestones like the signing of the charter (January 20), its formal organization (April 21), and its filing as a nonprofit organization in Minnesota (June 12). While much of our capital appeal work has involved celebrating Easter's long and vibrant ministry, we also intend to find ways to mark this special anniversary in Easter's history. Stay tuned. I'm always interested in a good reason to get together, have fun, and be reminded of how much good God is up to among us.

New pastors. I'll admit: Pastor Erik and Pastor Kevin don't feel very new anymore! They've fit in very well, quickly getting right to work to learn more about our community, build and grow programs and relationships, and work alongside staff and volunteers. But the truth is that they've been here just over a year, and for a pastor, that's still new!

I remain so grateful for their ministry. I have been personally sustained and encouraged by their wisdom, faithfulness, insight, and good humor. Professionally, I've been grateful for their leadership, preaching, humility, and ability to dream. Every day, I give thanks for the call committee, synod, and work of the Holy Spirit that called us together as church and pastors. Thank you for continuing to grant them grace, get them engaged, offer them your talents and time, and build strong ministry together.

A strong, hard-working staff. Through any changes, challenges, and chaos, Easter's staff continues to demonstrate just how talented, passionate, kind, strong, and faith-centered they truly are. We have a full staff with the additions of Holly Beck and Clark Nordberg, and we are well-prepared to keep moving forward on our building project with Gary Ehret. For the rest of the staff, whether they've been with us for one year or thirty years, they continue to demonstrate that they are truly capable and rooted in Christ. It is an honor to serve this congregation alongside each of them.

I know there will be more interruptions. Things will change or be unexpected or go far better than hoped or require a new direction entirely. But these are all invitations to consider where God continues to guide us. Sometimes it's also a reminder to me that the Holy Spirit is usually about three steps ahead of where I'm ready to go. But when you're surrounded by God's goodness, something you can't avoid at a church as engaged, compassionate, and faithful as Easter, you can continue to trust that God is at work in all things. As we move into our future together, I look forward to marking all of the incredible things that God has made possible in our midst.

Thank you, Easter Lutheran Church, for being a place that continues to live your faith in powerful and bold ways. It's an honor to serve God with you.

FAITH FORMATION

Dear People of Easter Lutheran Church,

As your called pastor for Faith Formation, I want to encourage you that everything related to Easter is forming faith in young people, young adults, adults, and elders—and the neighbors connected here at Easter. Faith Formation is a holistic, Holy Spirit-led, experiential adventure that is not limited to what happens on our campuses, also at your homes, workplaces, schools, soccer fields, and ice rinks, too. We have formal lessons we teach about being "saved by grace through faith" and Lutheran traditions and we have informal mentoring and experiences on what it looks like to be a follower of Jesus in 2024.

This all-encompassing perspective on faith formation is always grounded in what we are striving to accomplish as a community: to grow in faith and to carry on the work of Jesus Christ. Those two ideas are deeply woven together. In this past year, we have invited adults to grow in three key commitments: our understanding and relationship with God's Word in the Bible; prayer, our ongoing conversation with God; and Christian living, meaning, how does being a follower of Jesus provide us a lens to see our life and existence as a whole. How does being a follower of Jesus shape the way we love and serve our neighbor? How do we take a posture of learning and listening when our neighbor has something to teach us?

Significant accomplishments for the year:

- dult education. Church is the people; the body of Christ is a relationship with God and each other. When people say yes to helping up front or behind the scenes in the wide variety of learning ministries, lives are changed. Thank you for your ministry. Thank you for praying. Thank you showing up and helping us as a community fulfill the baptismal promises that we make to every person baptized in this church. The energy of small group leaders and the many roles throughout the church are a powerful witness that the love of God is active!
- de Easter Preschool celebrated its 30th year of ministry. What an accomplishment! Alicia Borman and her team have built something special.
- JAM (pre K-5th grade), grounded in the Jesus-centered *Orange* curriculum, continues to grow and evolve after the pandemic. Children are meeting Jesus through the good work of Rachelle Gill, Sara Currell, Mikayla Kvittem-Barr, and their team of volunteers. Vacation Bible School continues to be a powerful front door for Easter in connecting with families during the summer season. This is successful because of the long running summer staff program faithfully served by Summer Youth Interns, and in 2023 Katie Austin and Sophie Vigesaa led great youth ministry.
- Oconfirmation (gr 6-10), we celebrated in October 2023 with the 38 youth who affirmed their faith. Learning continues to offer a strong opportunity to grow in faith through middle school and high school years. Rotating between Old Testament, New Testaments and the Small Catechism, students are provided an expansive view of faith, church, and neighbor engagement. Deacon Hans Vigesaa creates fresh, engaging content each year and offers a compelling bridge to YOWIES. Middle school students are the key to Vacation Bible School and developing their gifts and skills of service.
- OWIES (gr 9-12) provide dependable, grounding community with relevant content, summer service trips, and student leadership. Deacon Hans and the core groups of adult leaders provide a safe, faithful place for students to grow.

- The TIM (Teens in Ministry) Team program is to be celebrated! High school students are practicing leadership skills and modeling for their peers a relational faith. They led weekly pizza parties for Confirmation during Lent where none had existed before, and it worked!
- Adult ministry thrives under Jami Day. Her connections and ideas helped build many fresh options for pastor-led content this past year. Thank you to the various group leaders, including Tom Yelle at ManUp, Shari Couch at Table Talk, Kathy Bahrke at OWLs, Laurie Martinson at WOW, Pastor Jerry Friest, and the many other leaders of adult learning and Life Group opportunities.
- 4 Praise God for the ordination of Pastor Amy Vigesaa at Easter.
- & We bid Godspeed to Allison Butler's faithful ministry at Easter and said "merhaba" to Holly Beck as Program Ministry Administrative Support.
- 4 We learned from the smaller number of weddings of the changing dynamics of marriage today and "church weddings."
- 4 We learned from our funerals how to continue to walk with people through depression, grief, suicide, health issues of many varieties, and how to name God's presence there.
- We added "noisy" offering buckets for children, beautifully built by John DeSutter, to help teach generosity in worship.
- With many new faces around the table, we as your staff team are learning new ways to work together. Jennifer Peloquin anchors our team with history, prayer, and technical knowhow; Holly Beck supports multiple staff members and programs; Amy Peschong and Raina Andrusko create magic communicating information to so many. Debbie Finley glues details together along with Clark Nordberg and ten-key boss Darci Dawson. Rhonda Doran holds Easter to our highest ideals as Christian neighbors, and nothing gets done, trust me, without our amazing facilities team of Butch Stodolka, Kerry Wollin, John DeSutter, and Al Dulas. The spring choral service, "All the Days of My Life," will be on May 12, with the Mill City String Quartet assisting. The Easter Choir, ably assisted by accompanist Mindy Eschedor, participates in worship most Sundays and the Jubilate Ringers at least six times throughout the year. The number of available ringers was insufficient for the Exultate Ringers to rehearse and participate in worship this year, but hopefully enough ringers will be available in the fall.

Sacha Pankratz, assisted by accompanist Tristi Wilson, continue to guide Easter's young singers in the Choristers, helping them to develop their singing technique, exposing them to choral music, and giving them the opportunity to be active participants in worship. The Choristers generally participate 2-3 times in fall/winter, including singing at the "Jingle Jam," and 2-3 times in winter/spring. As they did last year, the Choristers will also participate in the spring choral service on May 12, 2024.

We continue to enjoy the pipe organ purchased in 2020. It requires less frequent tunings than in the first year after it was moved to Easter. It does have some age-related maintenance issues (soldered connections of a type no longer used that are beginning to dry and flake apart) that will require attention in the near future.



WORSHIP - CONTEMPORARY

Significant accomplishments for the year:

- Livestream worship at the Lake started in December 2022. Thank you to **Randy Dufault** for installing the system and making this possible! This summer, Randy was able to add to the system and livestream outdoor worship. We now stream our 9 am worship service each week, and the online worship community continues to grow.
- ♣ A big thank you to **Sheryl Johnson** who redesigned and installed the artwork on the Great Room doors in March of 2023. They look amazing and bring much needed color and warmth to the worship space.
- ♦ Worship at the Lake happens because of a group of approximately 38 music and tech volunteers. These include singers, guitar players, bass players, keyboard players, drummers, software presentation volunteers, livestream volunteers, and sound volunteers. We are so grateful that they give their time and talent to bring worship to so many.
- ↑ 2 new projectors were installed in the Great Room in September of 2023. The brightness of the new projectors makes it much easier to follow along with worship than the previous generation of projectors. These projectors were purchased by the roofing company after some rain damage occurred to each projector during the roof install.
- ⊕ We worship twice a week at Easter by the Lake at 9:00 and 10:30 am. During the summer we move worship outside for one service a week at 9:00 am.

Big goals you're excited about for next year:

- ♦ There is lots of excitement around planning for a new sanctuary. I am looking forward to being a part of that planning process!
- ♦ I'm always looking to add tech and music volunteers to the Lake worship team.

One way you've seen the Holy Spirit active in your ministry this year:

I feel lots of gratitude for the amazing volunteers I get to work with each week. Not only are they a dedicated and talented bunch, but the Holy Spirit is present in the way they care for one another and minister to the people in our congregation and community.

Even though no similar initiatives were presented to the Foundation Team in 2023, it stands ready to respond should something be brought forth.

Big goals you're excited about for next year:

- ♦ The Foundation Team hopes to work with staff and/or church leadership to identify another significant churchwide special project that can be funded by the Foundation's Heritage Fund.
- The Foundation Team would like to continue to make the Easter congregation more aware of its purpose and framework and to help congregation members understand how they can invest in the mission and vision of the church during their lifetimes and beyond through the Easter Foundation.

OUTREACH REPORT

Easter's mission is to grow in faith and carry on the work of Jesus Christ. We actively strive to blur the lines between church and community, so that it is widely known that Easter exists to bless the world with God's love. Easter's Outreach Ministry and partnerships provide diverse opportunities for Easter people to answer God's call to love our neighbors and live into our shared vision and mission while impacting the lives of people close to home and around the world.

LOCAL PARTNERSHIPS

We are grateful for our continued long-term relationships with in-house outreach partners Loaves and Fishes, Homework Help by Reaching Up, and TreeHouse. Easter by the Lake is a lively hub of activity throughout the week. On a typical weeknight, Loaves and Fishes serves around 200 fresh, healthy meals to our local community. Guests have the option of picking up a meal to go or coming inside to dine in the Community Room. In addition to recieving nutritious food from Loaves and Fishes and The Open Door, students from five ISD 196 schools receive academic support at Easter every Monday through Thursday during the school year through Homework Help. Additionally, teens from throughout the South Metro gather for TreeHouse programming each Tuesday and Thursday evening, participating in large group activities and small group listening sessions with caring adults who believe that when we love teens and help them know their God-given value, it unleashes untold potential in their lives and our communities.

True to our community-centered model of outreach, Easter partners with organizations that care about the health and physical well-being of our community. Monthly we host a Red Cross Blood Drive, and a Fare for All sale, a low-cost option for lean meats and fresh produce, including a representative from Dakota County Career Services who provides on-site support to guests seeking new or different employment opportunities. Annually we host a MHealth Fairview flu vaccination clinic. As a founding partner of The Open Door food pantry, we continue to directly support healthy food options for our neighbors throughout Dakota County – including the summer Mobile Lunch Box program that brings healthy lunches into the neighborhoods of school children across three school districts.

Given Easter's intentional presence in our community, it's not surprising that people in crisis reach out to us for help identifying potential resources. Our relationship with 360 Communities is invaluable in these circumstances. 360 Communities provides critical care and stabilization to families in crisis and is particularly skilled in walking alongside families facing eviction. Easter directs funds to 360 Communities that trained 360 staff can access to stabilize families who are facing homelessness. Despite investing in eviction prevention, we know that lack of stable shelter is the reality for some of our neighbors. Easter's partnerships with CATCH (Coalition for Affordable Transitional Community Housing), and others including Dakota Woodlands, The Link, and MICAH (Metropolitan Interfaith Coalition Against Homelessness) respond to our most vulnerable neighbors.

There's so much to celebrate when we intentionally meet and embrace our full community! Large community events like Spring Fling in May and Art Block in September provide the opportunity

to celebrate together with the full spectrum of people who call Easter home – not just on Sunday mornings, but throughout the week. These events focus on "The Nature of Community" and celebrate that we are "Better Together." They complement other community events throughout the year such as God's Work Our Hands Sunday, our annual Loaves & Fishes Thanksgiving meal, and the Holiday Gift Shop, a tradition that has evolved to provide gift cards to families connected to Easter through our partners. Families use the cards to personally select gifts for their loved ones.

GLOBAL PARTNERSHIPS

Our new pastors have been busy learning about and developing renewed relationships with our partner congregations in Tanzania and Guatemala over the past year.

For more than 30 years, the people of the Saint Paul Area Synod, ELCA, and the Iringa Diocese of the Evangelical Lutheran Church in Tanzania have been walking beside one another as companions on a journey of faith, exploring God's mission together. "Bega Kwa Bega" is the phrase we use to describe this companionship. Meaning 'shoulder to shoulder,' it describes the way in which we accompany one another in a spirit of mutuality, inclusivity, and vulnerability.

Pastor Erik traveled to Tanzania in early 2024 to walk alongside our partners there. During January and February, he explored the ministry of the Iringa Diocese through excursions to diocese owned and operated schools, healthcare facilities, and parishes, including Easter's partner parish in Nyanzwa. While spending time in Nyanzwa, Pastor Erik was able to listen to the hopes and dreams of our growing partner parish. Soon after returning, he shared his learnings with Easter's Outreach Advisory Team. The Team was able to respond in support of a roof project for the newest preaching point in Mpilipili. Pastor Erik shared highlights of his travels with the wider congregation through a sermon and two information sessions.

The God Who Sees book study provided an opportunity to learn about the issue of migration from the personal perspective of Karen Gonzalez, a pastor who migrated to the US from Guatemala. Representatives from the Iglesia Luterana Agustina de Guatemela (ILAG) were able to join us for conversation around this important topic via Zoom, and a larger Synod-wide event in February provided the opportunity to learn more about the impact of migration on our ILAG partners directly from Pastor Karen Castillo and Diego Gil. We look forward to continuing this important conversation in the coming year. Additionally, we are excited to announce that for the first time in six years, an Easter delegation will travel for an in-person visit with our companion congregations in Guatemala City and Maya Itza, Guatemala. Pastor Kevin will lead this group visit in late January-early February 2025.

We sponsored Easter member Abbie Doran to live and serve for a year through the ELCA's Young Adults in Global Mission (YAGM) program. Abbie was placed in Jerusalem and the West Bank (JWB), she lived with a Palestinian host family just outside of Bethlehem and volunteered at the Evangelical Lutheran School of Beit Sahour. ELCA Global Mission suspended the JWB YAGM cohort after the events of October 7, 2023. Abbie then joined the Central Europe YAGM cohort and is currently completing her year of service in Nyíregyháza, Hungary. In March 2024, Abbie was able to join Easter's ManUp group via Zoom to share about her personal experience in the West Bank. Easter staff member Holly Beck, who previously served as a JWB YAGM in the 2022-23 cohort, copresented with Abbie.

Easter continued to partner with Lutheran World Relief and Lutheran Disaster Response to provide immediate assistance when natural and political disasters impacted our global neighbors. Through your generous donations, Easter was able to direct funds to these relief organizations for on-the-ground supplies and support in Turkey, Syria, Maui, and Gaza this year.

JUSTICE & EQUITY

At our annual meeting in April 2021, Easter's congregation adopted a resolution proclaiming our Christian belief and committing to working for racial justice by examining our congregational practices, organizing education opportunities, promoting equity among all people, opposing racism in all its forms, and building relationships of trust and solidarity in our community. This work continues under the leadership of Easter's Racial Equity Team and in partnership with the Center for Leadership and Neighborhood Engagement (CLNE). We welcomed guest preacher Pastor Kelly Chatman, a nationally respected teacher and speaker on multi-cultural leadership and community engagement.

At our annual meeting in April 2023, Easter's congregation adopted a Land Acknowledgement Statement. Believing this is holy work that requires more than acknowledgement, Easter continues to lean into opportunities to move beyond the land acknowledgement toward active participation in examining our practices, educating ourselves, promoting equity, and building relationships. Some of the ways we participated in this work included a Native Stories project for all JAM (Jesus and Me) students, a Why Treaties Matter exhibit, an exhibition and presentation by Native artist Kent Estey, collaborative learning with other faith communities, and Native guest preacher Dr. Kelly Sherman Conroy.

RIVERSIDE INNOVATION HUB – AUGSBURG UNIVERSITY CHRISTENSEN CENTER FOR VOCATION

Alongside congregational teams from 12 other faith communities, a team of Easter people began a two-year intentional learning journey, Thriving Congregations, in September 2023. Through this two-year learning cycle, participants are introduced to the theology, theory, skills, and values necessary to lead a faith community into deeper and more meaningful engagement with neighbors and neighborhoods. Exploration and training include the practices of accompaniment, interpretation, discernment, and proclamation as they relate to being a vital neighbor.

DREAMS FOR NEXT YEAR

Some of the things we look forward to:

- offering more group opportunities for travel including multigenerational visits to our partner congregations in Guatemala and an adult tour of the South following the Civil Rights Movement;
- the dedication of commissioned Native art by Dakota Hoska in conjunction with our land acknowledgment;
- completion of the accompaniment and discernment phases of the Riverside Innovation Hub vital neighbor intentional learning process;
- continued growth of the Fairbault TreeHouse planted by Easter member Amy Young.

SEEING THE HOLY SPIRIT AT WORK

We see the Spirit at work when we see the faces of everyone gathered in the Great Room at Spring Fling. We see the full beauty of this beloved community – Easter people of all ages, volunteers and participants of so many partner ministries, preschool families, and community members who know Easter as a good neighbor that strives to care well for all people – gathered in celebration of the breadth and impact of our shared calling to love God and love others. We see the Spirit when we share a meal together in Fellowship Hall at Art Block and read the messages left on the Nature of Community tree outside Fireside Commons – "When I walk through Easter's doors, I know I belong and it is home."; "When others reach out to welcome me it feels like I belong."; "We are from a Muslim background and our faith aligns with Easter Preschool style. Thank you for making my kids welcome to the community!"; "Being in this community brings me JOY!". And we hear the Spirit's voice as we work to become better listeners committed to hearing and sharing stories of hope and despair from all God's people.



ONE EASTER (ONE SITE) MINISTRY

Significant accomplishments for the year:

A Physical Development Task Force #1 (PDTF) was organized and met for the first time in late January 2023. The task force had the following 10 members: Sara Anderson, Abby Andrus, Derek Boeve, Gary Ehret, Cathie Ford, Sheila Gullickson, Jim Mattson, Brenda Misukanis, John Rollie, and Pastor Megan Torgerson.

The primary objective of the task force was to utilize the information assembled in the 2018 Master plan, evaluate, build on that information, and update the plan to move the ONE EASTER project forward with a plan, schedule, and budget. The task force was also asked to identify and hire. on behalf of Easter, a Capital Appeal Consultant to evaluate the ability to conduct a building appeal and to estimate our capacity as a congregation to raise funds to support a building project.

In August of 2023, the task force completed an updated comprehensive plan, a preliminary project development schedule, and worked with leadership to identify a preliminary project budget range. Also in August, the Capital Appeal Consultant, after completing a financial feasibility study recommended an appeal goal of \$6 million. A project finance team (subcommittee of task force) assembled a project financing plan based on four sources of funding: capital appeal results, borrowing, sale of the Hill property, and use of reserves.

A slightly modified task force (PDTF #2) was initiated in September of 2023. Mitch Berger was added to the original task force as an additional member.

The primary objective of this task force was to utilize the work of PDTF #1, to modify the plan to conform to the established budget total project cost (TPC) of not to exceed \$17 Million. This budget was based on the recommendation of the project finance team.

In January 2024, an updated project concept plan, budget and schedule were presented to the Vision Board. The Vision Board recommended this plan, budget, and schedule to the congregation. The congregation received this information at a congregational meeting on February 4, 2024. The congregation voted to proceed to the next level of design (schematic design), authorized funds, and a new building design committee was initiated.

Big goals to be excited about for this coming year:

A new building design committee has been initiated and met for the first time on February 5, 2024. The design committee has the following 10 members: Mitch Berger, Rick Dahl, Gary Ehret, Cathie Ford, Rachelle Gill, Neil Groon, Sheryl Johnson, Rolf Lokensgard, Jason Staebell, and Pastor Megan Torgerson.

The primary objective of the design committee is to work with the Architect HGA and Contractor (Langer Construction) team to design the new building project and get the building under construction in the fall of 2024.

One way we have seen the Holy Spirit active in this ministry this past year:

Beginning with the work completed in the 2018 Master Plan, the PDTF #1 and PDTF #2 task forces worked diligently to advance the project. Advancing a major building project through the many complexities was a significant challenge. The Holy Spirit was invited to guide our committee during each meeting to help us question, listen, discern, and decide as we progressed through each phase of the planning effort.

EASTER LUTHERAN CHURCH

ADULT MINISTRY

Significant accomplishments for the year:

- The most significant accomplishment this programming year was the addition of Pastor Kevin Bergeson to our team. Under his direction, we hope our members will find a pathway to a genuine, faith-filled community through the many learning opportunities at Easter. This past year focusing on three pillars: Bible, prayer, and Christian living.
- With the expertise of Raina Andrusko, we developed and mailed an Adult Ministry brochure for both programming seasons. These brochures made a significant impact on increasing awareness and participation in our programs.
- Pastor Kevin also created the new Program Ministry Team including children, youth, adult, and outreach ministries. Our goal with this new team is to work more closely together to live out our mission; to grow in faith and carry on the work of Jesus Christ.

No and Other Unexpected Answers to Prayer

Led by Pastor Megan Torgerson, we discovered a way to pray that connects with this season of your life. She taught how prayer is a conversation, but it does not always feel that way, and how to learn to hear God's voice. We had over 17 participants for this study.

Bible Basics: Danger Do Not Open

Pastor Megan led this study designed to help people better understand how to read the Bible. Answering these questions: Have you been led to believe that the content of the Bible is dangerous? Or that reading the Bible is scary? She helped build confidence in participant's Bible fluency, and explored four ways to enter the Bible and learn the whole story of God's love for us. We had over 11 participants.

Faith Ablaze: Reforming Faith for a Worried World

Pastor Erik Sevig explored why protests, thoughtful questioning and grace lit the Protestant Reformation over 500 years ago and how it can help you love your neighbor in a complex world. This had 17 participants.

Civic Life and Faith

This study, of over 16 people, led by Pastor Kevin Bergeson focused on how we live in a time where it's easy to give up on people. He explored how faith and civic life connect with a clear Jesus focus; to love your neighbor.

What Does This Mean? Life Questions; Faith Answers

Pastor Erik shared how to find support and reassurance in Martin Luther's *Small Catechism* as we try to make sense of this hustle culture. This was attended by 8 participants between the 2 sessions.

Who Chose This Hymn???

Ben Kornelis, Worship Director of Traditional Music, took us through the process of just how hymns are chosen. Together, the group planned the music for an upcoming service, followed by a hymn sing. This in-person event was very popular with over 30 participants.

Introduction to Centering Prayer Workshop

Presenter John Keller, a retired ELCA pastor and a certified presenter of Centering Prayer led a one-day workshop. Eighteen participants learned about centering prayer as a receptive, deep method of silent prayer that prepares us to receive the gift of the experience of God's presence within us.

Lenten Lunch Break Centering Prayer Zoom with Pastor Kevin

This new ministry, led by Pastor Kevin, included a 20-minute Zoom prayer session during Lent. This faith practice had between 5-8 participants and was received favorably. We hope to continue developing this ministry into the next programming year with further studies.

24 Hours that Changed the World

During Lent on Wednesdays, Pastor Kevin led this Noon in person and 7pm Zoom study with 30 participants. Drawing on insights from history, archaeology, and geography, this study provided a deeper understanding of the most amazing day in history. This was a meaningful way for us to reflect on the life of Jesus during the Lenten season.

Wrestling With Doubt

On Mondays, from January to March 2024, Pastors Megan and Erik led this study. The study tackled some tough questions: Where is God when bad things happen? Does God hear our prayers? Is there a heaven? How can we know? There were over 40 participants each Monday.

Pastor/Parent Huddle

This new ministry was designed to create a space for JAM families to gather with the pastor while their kids are finishing JAM. On the first Sunday of the month from January-April at the Lake, one of the pastors led an object lesson for the parents to act out at home. This kicked off the theme for each month of JAM. They also received a monthly devotional and a candle, and they were encouraged to create a time to read the devotional together.

Yoga

Linda Emeott, a registered Yoga instructor, continued to lead gentle yoga. This group is becoming a growing community of women, many of whom go to yoga after the WOW Bible study.

Soul Sisters

Pastor Megan continued to lead this popular and vibrant study on relevant topics for women of all ages. Members found this study to be very fun and engaging, as well as a safe place to ask honest questions about their faith. Amy Young, Merri Guggisberg and Beth Dean are instrumental in helping to create a welcoming community of women.

OWLS (Older Wiser Lutherans) The Call: The Life and Message of the Apostle Paul

Pastor Erik facilitated this study following the journeys of Paul, beginning with his dramatic conversion as he spread the gospel through modern-day Greece and Turkey. Under the leadership of Kathy Bahrke, this once-a-month community of retired men and women has grown significantly and continues to be a welcoming space that fosters friendships and faith.

WOW (Women on Wednesdays)

This year-round morning women's Bible study meets weekly, facilitated by Laurie Martinson. They listen to the pastor's podcast together prior to studying the Grow Guide written by Pastor Kevin. Pastor Megan continues to facilitate monthly to give the participants more insight into the pastor-written guide. Under Laurie's valued leadership, this amazing community of women is continuing to grow and become a welcoming and safe place to learn.

Table Talk - Animate Bible

Pastor Kevin joins the Table Talk team along with Shari Couch, as they continue to facilitate this daytime once-a-month study, which has good participation. Since last year's *Animate Faith* was so well-received, we chose to continue the series with *Animate Bible* this year. This curriculum focuses on building conversation using videos—which blend live action with animation—to introduce a question, provide a thought-provoking perspective, and beckon discussions. This study has been very well-received and therefore we plan to incorporate *Animate Practices* in the next programming year.

ManUp Men's Ministry

Easter Preschool's strength is in it's staff. Nancy Hensch, Theresa Glavan, Patty Goehring, Darla Landmark and Cindy Olson returned as classroom and Lunch Bunch teachers. The teachers are consistent but no two years at the preschool are ever the same. The teachers continue to educate themselves in best practices for early childhood. Research has proven time and again that learning through play is best. The environment is set and the children discover, problemsolve and collaborate. It's a joy to witness their growth.

Enrollment started lower than ever, grew in numbers but never filled to capacity. The budget reflects that. The budget also suffered from a number of snow and cold days pushing us to cancel many Lunch Bunch sessions. We even cancelled a Christmas family day for the first time ever.

A successful Art Block event kicked off the school year. Special thanks to Rhonda Doran, Director of Outreach, for partnering with the preschool. Free food, jumpers and art activities brought our communities together.

COVID protocols had classrooms wearing masks for 10 days if a classmate tested positive. Free test kits were made available to families through the Department of Human Services. Overall, the impact of COVID illnesses decreased over the year and protocols were easier to follow.

The use of our Brightwheel app continues to be an efficient tool for communication, billing, paperwork and attendance.

An additional 20 summer camp spots were offered during the afternoon of the June session.
